Dear Secretary DeVos:

We write today in the wake of the Department of Veterans Affairs' (VA) decision to suspend new G.I. Bill enrollments at several institutions of higher education—including forprofit University of Phoenix and schools owned by Career Education Corporation—as a result of unfair, deceptive, and abusive practices. We urge you to take action to protect federal student loan borrowers considering attending these schools.

In August, the Federal Trade Commission (FTC) announced a \$30 million settlement with Career Education Corporation. The FTC found that CEC and its subsidiaries used "an illegal and deceptive telemarketing scheme"—wrongfully obtaining consumer information and "falsely representing that its schools were affiliated with or recommended by the military."

In December, the FTC announced a \$191 million settlement with University of Phoenix over "deceptive advertising." The FTC found that UOP "falsely touted their relationships and job opportunities with companies such as AT&T, Yahoo!, Microsoft, Twitter, and the American Red Cross" in an effort to attract students. Specifically, FTC found that the deceptive advertising "targeted active duty servicemembers, veterans, and military spouses…".²

Relying on evidence gathered by the FTC in its investigation of CEC³ and University of Phoenix⁴, the VA found "sufficient evidence to support a finding that these schools have utilized advertising, sales, or enrollment practices that are erroneous, deceptive, or misleading..." in violation of 38 U.S.C. §3696(a).⁵ This provision of federal law states that "the Secretary [of Veterans Affairs] shall not approve the enrollment of an eligible veteran or eligible person in any

course offered by an institution" which engages in these practices. The statute provides authority for VA to rely on the FTC's investigatory expertise and findings in making determinations under this provision.

Now that the VA has taken action to protect new student veterans from being put at risk by enrolling in these schools, what steps will the Department of Education take? Specifically, we ask for your response to the following questions.

- 1. Has the Department of Education asked the FTC to brief Department staff on their findings in the CEC or University of Phoenix cases or requested FTC's evidence?
- 2. Has the Department of Education opened its own investigation into either of these cases?
- 3. Will the Department use evidence collected in these cases by the Federal Trade Commission or State attorneys general to establish findings and groups related to borrower defense?

We ask for your response no later than April 17, 2020. Thank you for your consideration.
